FACTs Grant & Aid (Tuition Assistance)

Cornerstone Christian Academy wants to put excellent Christ-centered, classical education within the reach of all families. When scholarship funds are available, preference will be given to those who have completed the application process in the order that the applications were received. This assistance will be awarded based on financial need with the financial assessment completed by the FACTs Grant & Aid Program. **Scholarship assistance is not available to families during their first year of enrollment.**

Peace of Mind Tuition Insurance

Cornerstone Christian Academy offers Peace of Mind tuition insurance through FACTs Tuition Management for \$20.00 per year per payment plan. This insurance offers a maximum coverage of \$30,000 per agreement in the event of a death of the responsible party or his/her legal spouse. FACTs will pay the remaining unpaid balance on the tuition payment agreement. Coverage is available for payers under the age of 70 at the time coverage begins.

Refund Policy

Enrollment and student fees are non-refundable and non-transferable. Tuition is charged for the school year in accordance with the payment plan selected by the family and is non-refundable upon mutual acceptance. In exceptional circumstances, such as an unexpected family move away from the area, the Administrator may authorize a refund upon written request. A move from the area is defined as seventy-five or more miles from the school.
